# FRENCHAND INDIAN WAR APPOINTMENT OF MILITIAMAN SIGNED BY COLONIAL GOVERNOR JAMES DE LANCEY

JAMES DE LANCEY (1703–60), Born in New York City, educated in England, was a noted jurist and one of the most important figures in colonial New York politics. He was a justice (1731–33) and chief justice (1733–60) of the provincial supreme court and served (1753–55, 1757–60) as lieutenant governor. His political dexterity enabled him to control both the council and assembly, and after the suicide of the governor, Sir Danvers Osborne, he assumed control of that office also. He led the De Lancey faction against Gov. George Clinton in politics and against the Livingston faction when that family expressed its Presbyterian opposition to the chartering of King's College (now Columbia Univ.) as an Anglican institution. He was presiding judge at the trial of John Peter Zenger and was president of the Albany Congress (1754).

# BRITISH VICE-ADMIRAL SIR CHARLES SAUNDERS RECEIVED 100 SAILORS ABOARD FOR "HIS MAJESTY'S FLEET" WHILE ANCHORED AT HALIFAX HARBOR WHILE ON HIS WAY TO THE SIEGE OF QUEBEC

SIR CHARLES SAUNDERS (1713 – 1775). British Admiral. Saunders commanded the fleet which carried General Wolfe's army to besiege Quebec in 1759 resulting in the most decisive battle of the War. ADS. 1 page. 7 <sup>1</sup>/<sub>2</sub>" x 4". Halifax Harbour. May 6, 1759.

"These are to certify that I have received from Mr. McKow, by the Endeavour Sloop one hundred seamen, for the use of his Majesty's fleet under my Command. Given my hand on board his Majesty's ship Neptune in Halifax Harbour this 6<sup>th</sup> day of May 1759."

The British fleet left England for America on February 16, 1759, arriving at the coast of Nova Scotia at Louisbourg on April 16. Ice left the harbour impassable so the fleet sailed south and anchored at Halifax until May 13<sup>th</sup> at which time it left for its Journey up the St. Lawrence river to Quebec subsequently besieging the City. This document was signed while the fleet was anchored at Halifax, just a week prior to setting off for the siege that would alter the course of the French-Indian War. This was signed aboard the Neptune, the largest ship of the fleet.

#### CONNECTICUT SIGNER OF THE ARTICLES OF CONFEDERATION \* 2

ANDREW ADAMS (1736-1797). Statesman. Adams was a member of the Continental Congress, Signer of the Articles of Confederation, and Chief Justice of the Connecticut Supreme Court. LAND WARRANT IN WHICH WILLIAM BINGHAM PURCHASES INDIAN LAND

printed land warrant issued by the common wealth of Pennsylvania and bearing a secretarial signature of governor THOMAS MIFFLIN (1744 - 1800); Signer of the Constitution; Revolutionary War general. Issued to the Deputy Surveyor of the commonwealth, the warrant reads in part: "Whereas William Bingham . . paid into the office of Receiver-General of the Land Office, the whole of the purchase money for one thousand acres of land within the last purchase made of the Indians, East of Allegheny river and Conawango creek, . . authorize and require you to survey . . for the said Wilhem Mellink . . the said quantity of acres . ." #### WILLIAM FRANKLIN SON OF BENJAMIN FRANKLIN ALS \* 6

WILLIAM FRANKLIN, (1731 - 1813). The illegitimate son of Benjamin Franklin. His mother's name was never revealed. Some suggested that Deborah may have been his mother but that Ben took all the blame to protect her honor because they were not yet married. Young William traveled with his father, attending school in England. Upon returning to America, William became Royal Governor of New Jersey. When the Revolution began, William remained loyal to England. With Ben in America and William in England, father and son found themselves on opposite sides of battle during the American Revolution. This forever strained their relationship. Ben's Last Will and Testament left nearly none of his wealth to William, claiming that if William's England had won the war, Ben would have never had any wealth to leave. ALS. 1 page. 6 1/2" x 8". ## ZEBULON BUTLER DS

**ZEBULON BUTLER** (1731-1795). Naval and Army officer. Butler saw service in the French and Indian War as an ensign, quartermaster and captain. With the outbreak of the Revolutionary War, he joined the Connecticut militia, and rose to the rank of colonel in the Continental Army, retiring at this rank at the close of the war. # BARTON TAUGHT MERIWETHER LEWIS METH-ODOLOGY FOR COLLECTION BOTANICAL SPECIMENS ON THE LEGENDARY LEWIS AND CLARK EXPEDITION

**BENJAMIN SMITH BARTON** (1766 – 1815). Physician and naturalist. Barton wrote the first textbook on botany in the United States, *Elements of Botony* which he published in 1804. Barton had originally planned to travel with Meriwether Lewis and William Clark on their legendary expedition but instead taught his close friend Lewis to properly collect and label specimens with their Latin names. When Lewis returned from the expedition with 226 plants, most were brought to Barton for inspection, classification and further analysis. In 1751, Benjamin Franklin was approached by his close friend, Dr. Thomas Bond, a prominent Philadelphia physician with the idea of creating a public hospital "for the reception and cure of poor sick persons, whether inhabitants of the province or strangers. He was zealous and active in endeavouring to procure subscriptions for it, but the proposal being a novelty in America, and at first not well understood, he met with but small success." (Franklin's Autobiography) Franklin's prominence and credibility in public works became the driving force in the successful financing of America's first incorporated hospital. Subscriptions to the hospital were matched by funds from the state assembly under the condition that Franklin and Bond could obtain private funds totaling 2,000 pounds which resulted in another Franklin success. The founding of the hospital, which Franklin stated was one of his most satisfying acheivements, certainly ranks as one of the earliest important subscription based financings in the United States. Lotteries had just come into existence a few years prior to this and had hardly been utilized to this point in time. Stock subscriptions were virtually unknown and thus the following items are extremely important not only in the fact that the hospital was America's first to be incorporated and financed with subscriptions, but also as an early innovation in American financial history

ELIPHALET DYER (1721 - 1807). Prominent longtime Connecticut figure. Dyer served during the French and Indian War, was appointed a lieutenant colonel in the Connecticut Regiment; again a member of the general assembly 1756-1784, serving as deputy from 1756 to 1762 and as assistant from 1762 to 1784; appointed comptroller of the port of New London in 1764; delegate to the Stamp-Act Congress in 1765; judge of the superior court 1766-1793, and served as chief judge from 1789 until 1793; Member of the Continental Congress 1774-1779 and 1782-1783; member of the committee of safety in 1775. #### **REVOLUTIONARY WAR GENERAL SAMUEL B. WEBB** WRITES FROM THE CONTINENTAL VILLAGE \* 11

SAMUEL B. WEBB. Revolutionary war general. Webb had a distinguished military career during the Revolutionary War. He was wounded leading troops at the battle of Bunker Hill, and was also wounded at the battles of White Plains and Trenton. He participated at the battles of Long Island and Princeton, and was captured during the Long Island raid in 1777. He performed several valuable administrative duties as well, serving as aidede-camp to Israel Putnam in 1775 and as private secretary to George Washington in 1776.

# **RARE BATTLE OF NEW ORLEANS DOCUMENT**

Consolidated report of the Guards mounted guarding a bridge and artillery emplacement at Camp Morgan on the West Bank of the Mississippi River across from the Chalmette battlefield near New Orleans. Listing of mounted guards. Signed by Captain Hugh Barfield of the 10th and 20th Consolidated Regiments of Louisiana Militia (Concordia and Feliciana Parishes). This was a base of operations protecting the West bank of the River from surprise attack by the British after their initial departure on January 17th. Jackson kept these Louisiana Militia forces in place for fear that the British forces would double back until the official word of peace came to him then the units were dispersed. IRVING BACHELLER (1859 - 1950). Journalist, novelist.In 1884, Bacheller founded the first newspaper syndicate in America, the Bacheller Syndicate, to supply special articles to large Sunday newspapers. One of the main contributions of this syndicate was the discovery of Stephen Crane and the serializing of the Red Badge of Courage. AUGUST BELMONT (1816-1890). Financier; Diplomat. At the age of fourteen, Belmont began working at the office of the Rothschilds in Frankfurt, Germany. His skill for finance won him numerous promotions within the company until in 1837, during the financial panic, he formed his own company in New York with his only tangible asset being that of his agency in the U.S. for the Rothschilds. 

Large graphic printed advertising from many local businesses surround the area of the page for visitors to sign. The book lists visitors from May 17, 1912 to October 15, 1914. There are thousands of visitor signatures including the well-known merchant.

J. C. Penny, Salt Lake City, September 16, 1875 - February 12, 1971

Minnie Sky Eagle, Chief Red Eagle, Pineridge Agency, South Dakota. Jan. 15, 1913 (All in one hand, this was written by one of the Chiefs or possibly for them by another individual)

Sam Rayburn July 4, 1913. Rayburn was the longtime Speaker of the House of Representatives.

The highlight of the book is a complete page signed by ten Blackfeet Indians including four Chiefs. The contingent of Blackfeet leaders from Glacier National Park, likely in Washington on tribal business visited the Confederate veterans home in Richmond on May 19, 1914. All have signed the book with their pictograph as follows:

## CHIEF EAGLE CALF Also known as John Ground. (CHIEF)

MEDICINE OWL (JOSEPH MEDICINE OWL was born in 1888)

## TWO GUNS WHITE CALF (CHIEF)

Two Guns White Calf (1872-1934), a Blackfoot chief, is bestremembered as a model for the "Buffalo Nickel." The face which appearson the nickel was actually a composite image made from the likenesses of three Native Americans, including Two Guns. Designed by James EarleFraser, the coin was first issued in 1913. Two Guns always maintained that he was indeed the sole model for the image on the coin and gainedcelebrity for this association. He was, for many years, the publicface of Northern Pacific Railroad, whose advertisements billed him asthe model for the coin, and a major attraction for the tourists whovisited Glacier National Park.



# **BIRD RATTLE** (**ELMER BIRD RATTLE**) was born in 1882 in of Blackfeet Nation, U.S.A..

An additional pictograph of a head is included but remains unidentified.

On April 18, 1883 a group of concerned Confederate Veterans met in Richmond, Virginia, to form the Camp Lee Soldiers' Home, class called Confederate Soldiers' Home, Confederate Veterans Soldiers' Home, R. E. Lee Camp Soldiers' Home, Lee Camp Soldiers' Home, or Old Soldiers' Home) as a benevolent society to aid their needy former comrades. The Robert E. Lee Camp, No. 1, Confederate Veterans was incorporated March 13, 1884. In the year that followed, the camp raised funds and acquired land in Western Richmond for a home. The Home opened on January 1, 1885, and it was located in the corner of Grove Ave. and the Boulevard in Richmond, Virginia. Plagued by financial difficulties, they sought money from the state. In 1886, the General Assembly authorized a small annual appropriation which was increased in 1892 in return for the deed to the property. The home was under the Dept. of Public Welfare until it closed in 1941, upon the death of the last resident. It would be another 20 years, Feb. 25, 1885, before the first permanent home — Lee Camp Soldiers Home — was opened in Richmond, Va. Because Union vets made contributions, it was dubbed a "monument to a reunited country."

The book remains intact though the binding is a bit loose. Overall it is in Fine condition. Offerings associating leaders of important American Indian such as this are indeed uncommon. 
**DOUGLAS FAIRBANKS**, Jr. (1909 - 2000). Actor. Starting in films as a young man, Fairbanks, Jr. followed in the footsteps of his illustrious father and spent over 40 years as a swashbuckler and leading man in Hollywood movies such as Party Girl, The Prisoner of Zenda, Gunga Din and Sinbad the Sailor.

CHARLES CHAPLIN (1889-1977). British film actor, director and comedian. Chaplin is perhaps the most famous figure in entertainment history.

**D. W. GRIFFITH** (1875-1948). Pioneer American motion-picture director and producer. Griffith developed early techniques which helped turn film making into an art, creating skillful methods of editing. Among his major works are The Birth of a Nation (1915), Broken Blossoms (1919), Isn't Life Wonderful? (1924), and America (1924).

SAMUEL GOLDWYN (1882 - 1974). Film producer, born in Warsaw, Poland. He emigrated to the USA as a child, and helped to found a film company, producing *The Squaw Man* (1913). He founded the Goldwyn Pictures Corporation (1917), Eminent Authors Pictures (1919), and finally Metro-Goldwyn-Mayer (1925), allying himself with United Artists from 1926. His 'film-of-the-book' policy included such films as *Bulldog Drummond* (1929) and *All Quiet on the Western Front* (1930). A colourful personality, many of his remarks have become catch phrases (*Goldwynisms*), such as 'include me out'.

In a rematch with Tunney in 1927, Dempsey again lost by a decision; in this famous fight, known as the Battle of the Long Count, Dempsey ignored the rule requiring a fighter to return to a neutral corner during the count after a knockdown. 



FRED S. DUESENBERG (1876 - 1932). Automotive engineer and manufacturer. Since the turn of the century, Fred Duesenberg had been well known as a designer of fast, powerful, reliable gasoline engines which came to be widely used in the marine, automotive and aviation industries. From 1903-1913 Duesenberg was the chief engineer of the Mason Motor Car Company. In 1913, Fred and his brother August established the Duesenberg Motor Company to manufacture gasoline engines of their own design. Success was immediate, with Mulford and Rickenbacker consistently driving Duesenberg-powered racers to commanding victories. In 1920 the brothers began to build their first production car, the Model A. While the car created a sensation at its debut, it was a mere shadow of the massive and extraordinarily expensive Model J (and later SJ and SSJ) which was introduced in 1928. Of the Duesenberg marque it has been said, "If but one of all the automobiles ever built in America had to be singled out as the most glorious achievement in this country's automotive history, that car would have to be the Duesenberg. It transcended the ordinary in full measure, created legends in its wake which will live forever, and became a literal metaphor 'It's a Duesy' - for anything unrelentingly superlative."



Rules for attending to tasks such as annual and special meetings of the shareholders were also defined. In essence, in this meeting, the organization defined the terms of its own existence. Because of the listing of the by-laws of the corporation, these minutes, signed as usual by **Thomas Edison**, **Charles Edison**, and the rest of the Board, are of far greater importance than these of more commonplace meetings, and estimated accordingly. 





WILLIAM MERVINE (1791–1868). Naval Officer. Served on the Great Lakes during the War of 1812. Appointed to command Gulf Blockading Squadron, 1861; promoted commodore, 1862, rear admiral in 1866.

JESSE DUNCAN ELLIOTT (1782 – 1845). Naval Officer. In command of naval forces on Lake Erie, 1812. He was  $2^{nd}$  in command to Commodore Perry at Battle of Lake Erie.

DANIEL TODD PATTERSON (1786 – 1839). Naval Officer. In 1813 he commanded New Orleans station; he captured 6 schooners and other small vessels of pirate Jean Lafite, 1814; caused enemy delay by gunboat action on Lake Borgne, aiding General Andrew Jackson's final victory.

FOXHALLALEXANDER PARKER (1821–1879). Naval Officer. In 1861, he manned Ft. Ellsworth, Alexandria for defense of Washington.

SILAS HORTON STRINGHAM (1797 – 1876). Naval Officer. Commanded Atlantic Blockade Squadron in Civil War.

LAWRENCE KEARNY (1789 – 1868). Naval Officer. Commander during the War of 1812; Commanded East India Squadron from 1840-43.

**LOUIS MALESHERBES GOLDSBOROUGH** (1805 – 1877). Naval Officer. War of 1812; commanded mounted volunteers in Seminole War; served in the Mexican War. From 1859-61, Atlantic Blockading Squadron, 1861; cooperated with General Burnside in capture of Roanoke Island.

ISAAC CHAUNCEY (1772 – 1840). Naval Officer. Served in the war with Tripoli; commanded naval forces on lakes Ontario & Erie during the War of 1812.

In November 1985 in Geneva, Switzerland, Mikhail Gorbachev and Ronald Reagan met for the first time to discuss issues such as SDI and the reduction of nuclear weapons. However, after meeting, tensions still remained due to fighting in Afghanistan and Central America. After months of postponement a mini-summit was organized in Reykjavik, Iceland, to open communications further. There, the two leaders again discussed SDI at length but also made progress toward agreements to reduce ballistic missiles by 50 percent and a "zero option" agreement in Europe — meaning there would be no more intermediate-range missiles in Europe. While no agreement was signed in Reykjavik, both leaders felt that the meeting was a success and opened the way for further progress. SP- color. Oct. 17, 1988. It was apparently fired behind the scenes upon the right of the stage and behind the Presidents box. While it startled everyone, yet it was evidently accepted by everyone as an introduction to some new passage... The assassin of the President, is about five feet nine and a half inches in height, black hair, and I suppose, black eyes. He did not turn his face more than quarter front, as artist term. His face was smooth, as I remember, with the exception of a moustache of moderate size. He was clad in a black coat, approximating to a dress frock coat, dark pantaloons and wore a stiff-rimmed, flat topped, round-cornered black hat of felt ....

"The Great National Tragedy.....The Monstrous crime of Friday night shocked this city with an agony unutterable. Yesterday morning men walked the streets and looked into each other's eyes, and found no words willing to leave their lips. Their hearts were surcharged with grief and a wrath inexpressible. That any Rebel even could be so base as to

assassinate the man who within the past ten days has held out the olive branch of peace, and exhibited so great a desire to forgive, was a crime for which Washington, as well as a nation was unprepared......"

# AN EXTREMELY RARE JOHN BROWN'S HAIR FROM HIS HEAD AND BEARD WITH SUPERB PROVENANCE

**JOHN BROWN** (1800-1859). Abolitionist, chiefly remembered for his raid on Harper's Ferry. From his youth, Brown held a deep rooted hatred for slavery but was well over fifty before the idea of freeing the slaves by force dominated his mind. His raid on the United States arsenal at Harpers Ferry along with 18 followers was to undertaken to gain arms and be the catalyst for a slave rebellion. On October 16, 1859, the small band captured the arsenal only to be confronted by troops commanded by Colonel Robert E. Lee. The fort was forced open on October 18 and Brown was delivered for state trial. Convicted on charges of treason, he was hanged on December 2, 1859.

## Two Tufts of hair

Two groups of numerous strands of hair both meticulously placed into a period photograph case with provenance. The hair has been sewn

onto a card stock with the following penned onto the card;

- 1) "A lock of hair from John Brown's beard".
- 2) "Lock of hair from his head"

Presented to G. W. Steel by Salmon Brown, son of John Brown.

Salmon Brown was the tenth of John Brown's twenty children. He fought alongside his father in Kansas but did not participate in the Harper's Ferry raid. He died in Oregon in 1919 He was an Oregon resident and is buried in the GAR cemetery in Portland.

W. G. Steel is considered the "Father of Crater Lake National Park" and was its second superintendent. His parents were abolitionists and their home served as a station on the underground railway. Following quotation is taken from the August 31, 1911 entry in the Crater Lakes Special Events Log:

"Will Steel makes a journey to his boyhood home of Stafford, Ohio where he tours the old Steel family home. Since his family had been heavily involved as abolitionist in the Underground Railroad in Ohio, one could still view of the four secret panels and the tunnel that connected to the Steel store. Will corresponded with several of John Brown's children for a number of years."

These locks of hair with a number of photos depicting W. G. Steel's wife and his in-laws were recently discovered in the attic of the California home of a family who built and operated the Upper Springs Resort in Dunsmuir, CA — about 50 miles from Crater Lake. The family shared a common interest with W. G. Steel in mountaineering and they were accustomed to traveling in a social circle that included John Muir and quite probably, W. G. Steel.

Clearly, Steel was a close and respected friend of the Brown family to have received such a personal gift. In all likelihood, the common bond they formed during their struggle against slavery remained with them for the rest of their lives. This is the first and finest offering of John Brown's hair with such a provenance we have seen. The two separate tufts being from his head and famous beard may be unique. I attended the full courses of lecture at the New York Medical College and graduated at the institution...I have been occupied over three years in the study of Medicin. My opportunities for acquiring a knowledge of Pharmacy and the physical properties of drugs have only been such as are usually employed by Medical students. For witnessing the practice of Medicine and surgery I have been for three months junior asst. physician at Bellevue Hospital and nearly a year House Physician and Surgeon to Island Hospital, Blackwell's Island...."

Accompanying the letter of application is a three page test in which candidate Whitney provides answers to eight different medical questions. Questions #2 asks "What are the various forms of syphilis and how treated?." The final document is a "Certificate of Physical Capacity in which Dr. Whitney declares that he is healthy and fit for the position. Whitney's application was successful as he went on to serve as assistant surgeon aboard the USS Colorado in July of 1861. 

ALBERT LEO, FRANCIS HENRY, GEORGE THOMAS, JOSEPH EU-GENE AND MADISON ABEL SULLIVAN were born in Waterloo, Iowa, between 1914 and 1920. George and Francis enlisted in the Navy in 1937. Their three younger brothers joined the service in early 1942. All five were assigned to the commissioning crew of USS Juneau (CL-54) in February 1942. They remained with the ship through her Atlantic shakedown operations and subsequent combat actions in the Guadalcanal Campaign. All were lost with her on 13 November 1942, a tragedy that received wide publicity in the United States and resulted in a new Navy policy discouraging family members from serving to gether in the same ship.

In the aftermath of Juneau's loss, the Navy notified Mr. and Mrs. Thomas F. Sullivan of Waterloo, Iowa, that all five of their sons were missing in action. Two of the brothers had served previous four-year enlistments in the Navy and so, when all five brothers enlisted together on 3 January 1942, the Navy was the obvious choice. They had also insisted on serving together on the same ship. Although the accepted Navy policy was to separate family members, the brothers had persisted and their request was approved. It was later learned, through survivors' accounts, that four of the brothers died in the initial explosion. The fifth, George Thomas, despite being wounded the night before, made it onto a raft where he survived for five days before succumbing either to wounds and exhaustion or a shark attack. The brothers received the Purple Heart Medal posthumously and were entitled to the American Defense Service Medal, Fleet Clasp; Asiatic-Pacific Campaign Medal with four engagement stars and the World War II Victory Medal. They had also earned the Good Conduct Medal.An extraordinary World War II patriotic poster which serves as a glaring reminder of the sacrifices made by American's servicemen throughout our history.
