JAMES BUCHANAN (1791-1868). Fifteenth President. Buchanan was from Pennsylvania and he served in a variety of posts before the Presidency, including service in the Pennsylvania House of Representatives and the United States House of Representatives, Minister to Russia and Great Britain, United States Senator and Polk's Secretary of State. He defeated Fremont for the Presidency in 1856; during his term he dealt with the Panic of 1857, Bleeding Kansas and the secession of the Southern states, which he left to Lincoln.

To the Hon. F. W. Pickens:

"I have received your kind letter & most cordially reciprocate the friendly feelings which it manifests for myself. I am glad that you approve of my witdrawal. Mr. Van Buren never was, neither my first or second choice for the Presidency as you well know; and I have never concealed this opinion. When, however, it became clear as the light that he would be nominated - nay that he had already been nominated in fact, if not in form; I felt it to be a duty which I owed to my country & my party to withdraw from the hopeless contest. My continuance in the field could have produced not effect but injury to my party, my friends & myself.

God knows what may be the result of the next Presidential election. Should the Whigs prevail & Clay be elected, it may be long very long before Democratic principles shall regain the ascendency. From his very nature, however, might carry Whig principles to such an excess in practice as to destroy his party.

I can scarcely venture an opinion as to the vote of Pennsylvania. I think, however, that when the war begins to be fairly waged, & the forces are marshalled, the old Democratic spirit will rise & conquer. In his principles, I trust, they will forget these objections to the man.

I confess I am alarmed by your suggestions. I presume that the developments to which you refer relate to Mr. Calhoun's forthcoming letter. I have only heard vague reports as to what it contains.

The present three days wonder is the letter of Mr. Reves. He can carry little or no strength with him; but still it is a symptom that he believes Mr. Clay to be in the ascendant. Those who know him best say that he has an unerring instinct for discovering the strong side. How a man who has all his life been opposed to a Bank, distribution and all the other federal heresies proceeding from a latitudinarian construction of the Constitution can now turn round & support the great apostle of all these doctrines, I am utterly at a loss to comprehend."

Prior to the election of 1844, Buchanan's Pennsylvania supporters had mentioned him as a "favorite son" candidate for the Democratic Presidential nomination. However, as indicated in this letter and a historical fact, Buchanan withdrew prior to the convention in deference to the party. Upon the election of Polk, Buchanan was appointed Secretary of State. This letter offers a fine glimpse into Buchanan's mindset concerning the political forces arrayed against both himself and his party at the time. In addition there are collected each month from 23 cities of New York State information as to the number and estimated value of the building permits issued ... The only State in which any extensive returns are secured from building employers in Ohio...The U.S. Bureau of Labor Statistics has not yet entered the construction field...New York State was the pioneer in collecting information from manufacturers ... "The undersigned, Otis F. Glenn and William H. King, tellers on the part of the Senate, Lamar Jeffers and Charles L. Gifford, tellers on the part of the House of Representatives, report the following as the result of the ascertainment and counting of the electoral vote for President and Vice President of the United States for the term beginning on the fourth day of March, nineteen hundred and thirty-three."

A printed large document printed and signed by the tellers of the House and Senate officially announcing FDR's landslide victory over Herbert Hoover. This document was printed by the Government Printing Office just after the election in 1932 and apparently distributed internally to members of the House and Senate to officially notify them of the results. The results of each state details votes cast for both Presidents and Vice-Presidents and detail one of the largest defeats in Presidential election history.

The whole number of the electors appointed to vote for President of the United States is 531, of which a majority is 266.

Franklin D. Roosevelt of the State of New York, has received for President of the Untied States 472 votes; Herbert Hoover, of the State of California, has received 59 votes.

The state of the vote for Vice President of the United States, as delivered to the President of the Senate, is as follows:

The whole number of the electors appointed to vote for Vice President of the Untied States is 531, of which a majority is 266.

John N. Garner, of the State of Texas, has received for Vice President of the United States 472 votes; Charles Curtis of the the State of Kansas, has received 59 votes.

This announcement of the state of the vote by the President of the Senate shall be deemed a sufficient declaration of the persons elected President and Vice President of the United States, each for the term beginning on the fourth day of March, nineteen hundred and thirty-three, and shall be entered, together with a list of the votes, on the Journals of the Senate and House of Representatives."







[HENRY CLAY] "Gentlemen, I have received your letter of invitation to attend a public meeting in the city of New York, "for the purpose of (-) the name of the Hon. They agreed to "pay to THE UNITED STATES LITHOGRAPH COMPANY or order, Five thousand three hundred and seventy two 41/100 Dollars with interest from date until paid, at six percent per annum". Cody's Last Ride Into The Sunset By 1910, William "Buffalo Bill" Cody was a worn, sixty four year old man. For the previous forty years, he had lived on the road, performing with the Wild West Show. He had given the show wonderful thousands of times, pleasing hundreds of thousands of people of all ages. Yet for all the thousands of paying customers, Cody did not grow wealthy. The constant expense of moving animals and show props gnawed at his profits. For years, his investments in ranches, stocks and real estate, failed to grow. His financial manager, Nate Salsbury, kept the show viable, but when Salsbury died in 1902, Cody knew there might be trouble. He turned to James A. Bailey of circus fame to manage the legendary Wild West show. When Bailey died in 1907, the show was slightly in debt, and Cody knew he needed financial help quickly. In addition to debt, Cody saw the new threat that loomed, motion pictures. No longer did people have to pay Cody to see the relics of the Wild West; for just a few cents, they could enjoy a moving picture of horses, Cowboys and Indians. In addition, movies could show the spectacular Western panoramas that Cody could not. Fortunately for Cody, an old friend was willing to make a deal to help both of them. Gordon "Pawnee Bill" Lillie was another Western showman. He managed the Pawnee Indians for the Wild West Show in the early 1880s before he left to run his own Pawnee Bill's Far East Show, Like the more famous Cody, Pawnee Bill also faced the threat from movies. The two old friends struck a simple deal in 1910 that was mutually beneficial. Cody was the better known performer, so the two men would capitalize on Cody's name. Pawnee Bill was the better businessman who had some financial resources, so the two would use Pawnee Bill's money to fund the show. The men were going to have a "farewell tour" intended to visit every town n the United States and Canada, and they hoped it would last three years.

BENJAMIN CURTIS (1809 - 1874) Nominated to the Supreme Court by President Millard Fillmore in 1851, and he remained on the Court for six years. Curtis is known for his opinions in two cases: Cooley v. Bd. of Wardens (1852), and Dred Scott v. Sandford (1857). In Dred Scott, Curtis dissented from the Supreme Court's holding that the Court lacked subject matter jurisdiction because Dred Scott was not a citizen of the United States, and from the Court's dictum that the Missouri Compromise of 1820 was unconstitutional. Curtis resigned in dismay and disgust from the Court after Dred Scott was decided. Curtis was only 47 when he resigned from the Court. He returned to the practice of law in Boston after resigning, and acted as defense coursel to Andrew Johnson during Johnson's impeachment trial in 1868. Curtis was thrice married, and was the father of 12 children.

A superb archive of 37 mostly multiple page letters entirely written by Supreme Court Justice Benjamin Curtis to his longtime friend E. M. Stoughton. The letters span a period of 1858 – 1873 and a number of them were written during the Civil War. A great deal of personal content as well as legal business matters are discussed



He writes of the death of his second wife in 1860 on mourning stationary; "I am truly grateful to you for your sympathy...no one can know as I do who have () fourteen years of love, honor and harmony with her, without a moment's interruption, even by a hasty word, & have seen her go away with the sweet composure on her feel, which was in her heart...Curtis continues on with the details of her illness. Letters discussing "The Corliss case" which was a patent dispute provides some considerable detail on legal work that he may have been involved in with Stoughton.

A letter in which he indicates desire to do his duty as a voter in the upcoming election "I can not leave here so as to be in New York...to have a conversation with you, without neglecting what I feel to be a duty – but to vote here. Will you please say to Judge Nelson that Mr. Wm. Appleton is a candidate for Congress in the District where I am a voter...& every ballot is important..."

A reference to his legal work during the war mentions enemy prisoners. "I am going to Maine to argue the first of the insurance cases arising out of the **Confederate Captives**."

Concerning the loss of a case he felt storngly about Curtis scathes the court.

These letters bear out the loss of three children and his second wife thus offering a personalized view of the great sadness surrounding Curtis' career and the emotional drain he must have been suffering while being looked to for legal leadership. I have also, inclosed [sic] a copy of the additional instructions, which the Governor has issued on that subject, in consequence of the present situation of the public affairs. If, at any time, you should judge the augmentation of your force necessary, to repel any actual...hostilities, from any quarter, you will, with all possible dispatch, communicate your situation to Govr. Wilkins junr. or to the Brigade Inspector of Allegheny County, who have direction to exert themselves for your relief. Still, however, you are to consider yourself as bound to act merely on the defensive, agreable [sic] to the Governor's orders of the 1 Ulto.; to avoid every appearance of aggression, consistently with the execution of you trust; and to conciliate the good will of the Indian, or British, settlers, in the neighborhood of the County, through which you march. As the season for commencing your march approaches, you will...Genl. Wilkins, from a consideration of the actual...of the country, and of your indulgence respecting any mediated opposition, how far you ought to advance, in order to fix a place of rendezvous for the different parts of your detachment, and the Commissioners. It is presumed that you maintain a regular correspondence with those Gentlemen; whose security is the object of the Detachment under your command, and whose instructions ought, therefore, to be punctually regarded. In addition to these intimations, the Governor directs me to repeat his desire of hearing from you on every interesting occasion." The Whiskey Rebellion, which took place in western Pennsylvania near Pittsburgh, was the first direct challenge to the new authority of the Federal Government. In 1791, Treasury Secretary Alexander Hamilton needed to raise revenue to pay for the Federal Government's assumption of the state debts from the American Revolution. He raised the excise taxes on spirits, which affected Pennsylvania farmers, who thought they were paying an unfairly large share of the tax. Some distillers refused to pay the tax, so the Federal Court in Philadelphia ordered their arrest. When served with the papers, the distillers attacked the Federal officers. President Washington, determined to show the new government's supreme authority, asked the insurgents to stop and requested that the governors of New Jersey, Maryland, Virginia and Pennsylvania raise 13,000 troops, which Washington personally inspected. The troops were gathered at Carlisle, Pennsylvania and when the fighting did not stop, they marched west. The rebels quickly scattered when the troops approached. A few leaders were arrested and convicted, though the merciful Washington later pardoned them. The letter is in dark ink. 



With best wishes your friend G.W. Lillie". About 1910, Cody realized his Wild West Show was losing money at an alarming rate, due in part to motion pictures. Lillie and Cody decided to join forces for a three year Farewell Tour that did well the first year, but flopped in the second. Soon, creditors, such as the United States Lithograph Company that produced all the show's posters, encircled Cody, looking for their money. Codywas unable to pay, so he agreed to Harry Tammen's ludicrous offer of a six month note of \$20,000, using the Show's property as collateral. 





The Ayers gave me six big gold buttons for white vest a gold knife a case of six beautiful silver knives and B gave me a silver picture frame to carry in my pocket with two places for pictures one for you and one for Pa. 





Bryan also called for tariff reform, control of the trusts, an income tax, direct elections, government rather than private issuance of money, an end to "federal interference" and "government by injunction," and liberalization of the Supreme Court. 
